Be careful using any of the information provided here – it could well be inaccurate. If you want to be certain, try googling the address or number you want to use.

Please be respectful when dealing with these people. Save your witty insults for your social media, simply get down to business when corresponding with a jobactive person. You never know, your messages might be made public.

And finally, a big thanks to all the leaders who ensured their contact details would be easily found by the public. You must understand that leadership is about more than an elevated social status or a fatter pay packet, and that sometimes being in charge means accepting responsibility for all the bad things your organisation has done, as well as the good.

The initial aim of this project was to acquire the email addresses of JSP CEOs. This has been expanded to include any leader figure whose contact details are available online.

The more complete sets of contact details were found on [training.gov](#), the government's register of VET providers. Others emails were scraped from LinkedIn using [RocketReach](#). The rest were found through a combination of frantic Googling and inspired guesswork.

Unsubstantiated, yet seemingly plausible guesses, are marked with an asterisk(*). The more asterisks, the more cautiously you should use the information.
